In respect of this schedule, please note the following:

1. The term “General Government [Budget] Committee” describes an “expanded” General Government Committee, chaired by the Deputy Mayor and comprised of all the members of Council, including the Mayor.
2. While all the meetings are open to the public, the public will be specifically invited to attend,
 - **on January 18 to be able to hear the “special staff presentation”, as a basis for future public presentations to Committee;**
 - **on February 1 to make presentations in respect of any aspect of the budget, after Committee has considered each element of the budget at least once; and**
 - **at the regular Council Meeting, prior to final consideration and adoption of the various elements of the budget.**

In camera meetings may need to be scheduled.

3. The schedule will be published in the newspaper and on the City website for the information of the public throughout the budget processing period. (Publication of notice of the meeting at which Council intends to adopt the budget is required by the *Municipal Act, 2001*.)
4. In most cases relevant materials will be delivered to Council members in their package on the Friday before each meeting. Where that is not possible, every effort will be made to distribute them in advance of the meeting.
5. The starting time for meetings on Committee nights may need to be moved up depending on the other agenda items scheduled for the same night. This will be monitored closely and notice of time changes will be given.
