THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 2000-146

BEING A BY-LAW TO REVISE THE SALARIES PAYABLE TO THE MAYOR AND COUNCILLORS OF THE CITY OF NORTH BAY AND TO REPEAL BY-LAW NO. 144-88 & 145-88.

WHEREAS Council appointed an independent committee to study and report on the matter of Council salaries;

AND WHEREAS by Clause No. 1 of General Government Committee Report No. 2000-07 passed by Council at its Regular Meeting held on Monday, May 29,2000 Council adopted the report of the independent committee and approved a new salary schedule for the Mayor and Councillors;

AND WHEREAS pursuant to the provisions of the *Municipal Act*, R.S.O. 1990, c.M.45, as amended, Section 242, the Council of The Corporation of the City of North Bay deems it advisable to revise the salaries payable to the Mayor and Councillors as aforesaid.

NOW THEREFORE THE COUNCIL OF THE COWORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1. (1) That each Councillor of The Corporation of the City of North be paid an annual allowance effective December 1,2000 of \$16,000.00 per annum, of which one-third shall be deemed to be for expenses incident to the discharge of his/her duties as a member of the Council.
 - (2) That in addition to the annual allowance payable him/her as a Councillor, the Deputy Mayor shall receive an additional allowance effective December 1,2000 of \$1,600.00 per annum, of which one-third shall be deemed to be for expenses incident to the discharge of his/her duties.
 - (3) That the Mayor of The Corporation of the City of North be paid an annual allowance effective December 1,2000 of \$50,000.00 per annum, of which one-third shall be deemed to be for expenses incident to the discharge of hisker duties as a member of the Council.
- 2. That the allowances herein set out shall be paid monthly, not in advance.
- 3. That this By-law shall come into force as of the 1st day of December, 2000.
- 4. That By-law No. 144-88 and By-law No. 145-88 of The Corporation of the City of North Bay are hereby repealed.

READ A SECOND TIME IN OPEN COUNCIL THIS 11TH DAY OF DECEMBER, 2000.
