

**The Corporation of the City of North Bay**

**By-Law No. 2020-02**

**Being a By-Law to Amend By-Law 2011-234  
to Regulate Parking in Municipal Parking Lots  
Schedules "B", "C" and "D"**

**Whereas** the *Municipal Act*, 2001 as amended, Section 11(3) permits a Council of a local Municipality to pass by-laws respecting parking, except on highways for the purpose of regulating, supervising and governing the parking of vehicles on land owned or occupied by the Municipality;

**And Whereas** Notice of the Public Meeting in the matter of the fees charged in Municipal Parking Lots within the City of North Bay was given by way of an advertisement in the North Bay Nugget on the 14<sup>th</sup> day of December, 2019 and the 21<sup>st</sup> day of December, 2019;

**And Whereas** a Public Meeting under the *Municipal Act*, 2001, as amended, in the matter of the fees charged in Municipal Parking Lots within the City of North Bay was held on January 6, 2020;

**And Whereas** Council approved the amendments to the Municipal Parking Lots By-Law by General Government Committee Report No. 2020-02 passed on the 14<sup>th</sup> day of January, 2020.

**Now, Therefore, the Council of The Corporation of the City of North Bay Hereby Enacts as Follows:**

1. That Section 3 (Pay and Display Lots) to Municipal Parking Lots By-Law No. 2011-234 (as amended by By-Law 2016-77) is hereby deleted and the following inserted in lieu thereof:

**"3. Pay and Display Lots**

No person shall park a motor vehicle on Parking Lots Oak 2, McIntyre 3, McIntyre 4, Main 5, Worthington 6, Worthington 7, Wyld 8, Oak 10, and McIntyre 11 between 8:00 a.m. and 4:30 p.m. on any day except Saturday and Sunday:

- (a) unless a receipt issued by the machine for that vehicle is clearly displayed on the driver side dashboard of the motor vehicle, or parking payment has been purchased and confirmed through the on-line payment system to be current and valid for the vehicle in the location where it is parked;
- (b) Lots Oak 2 and McIntyre 4 will also require the insertion of the correct license plate number in addition to the information in paragraph (a) above;
- (c) in no case longer than the expiry time stipulated on the receipt, or in no case longer than purchased and confirmed through the on-line payment system; and
- (d) in no case longer than the maximum authorized time for that parking lot as stipulated by Schedule "B" hereto."

2. That Section 4 (Monthly Parking Lots) to the Municipal Parking Lots By-Law No. 2011-234 (as amended by By-Law 2016-77) is hereby deleted and the following inserted in lieu thereof:

- "4. (a) The Parking Supervisor or his/her authorized delegate is hereby authorized to issue permits for the purpose of monthly parking in areas and at the rates stipulated in Schedules "C" and "D";

- (b) No person shall park a motor vehicle in the areas designated for monthly parking in the lots stipulated in Schedule "C" hereto without displaying an authorized permit.

3. That Section 7 (Monthly Parking Lots) to the Municipal Parking Lots By-Law No. 2011-234 (as amended by By-Law 2017-63) is hereby deleted and the following inserted in lieu thereof:

"7. No person shall park a motor vehicle in any parking lot overnight from 12 midnight to 8 a.m. from November 1<sup>st</sup> to March 31<sup>st</sup> inclusive, with the exception of:

(i) Oak Lot 2 (in designated areas):

- (a) with a valid Overnight Winter Parking Pass visibly displayed on the dashboard; or
- (b) an Overnight Winter Parking Pay & Display nightly receipt visible on the dashboard; or
- (c) an Overnight Winter Parking payment that has been purchased and confirmed through the on-line payment system to be current and valid for the vehicle in the location where it is parked; and

(ii) McIntyre Parking Garage (Lot 4) Levels 1 to 4

- (a) No fee charged between 4:30 p.m. and 8:00 a.m.

4. That Schedule "B" to Municipal Parking Lots By-Law 2011-234 (as amended by By-Law 2016-77) is hereby deleted and the attached Schedule "B" is inserted in lieu thereof.

5. That Schedule "C" to Municipal Parking Lots By-Law 2011-234 (as amended by By-Law 2016-77) is hereby deleted and the attached Schedule "C" is inserted in lieu thereof.

6. That the attached Schedule "D" is hereby added to Municipal Parking Lots By-Law 2011-234.

7. This By-Law comes into effect on April 1, 2020.
