

THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 127-82

BEING A BY-LAW TO AMEND BY-LAW NO. 28-80
TO REZONE CERTAIN LANDS ON CARMICHAEL DRIVE
FROM (M.4) TO (M.5) AND FROM (M.4) AND (A)
TO (RME) (NORTHERN BRICK AND TILE)

WHEREAS upon the request of the property owner concerned and with the approval of the local Planning Board, it is considered advisable to amend By-Law No. 28-80 of The Corporation of the City of North Bay to amend the zone designation shown on Schedule "C-6" of By-Law No. 28-80 pursuant to Section 39 of The Planning Act, R.S.O. 1980, Chapter 379;

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. Schedule "C-6" of said By-Law No. 28-80 is amended by changing the zoning designation on that part of said zoning map set out in Schedule "A" attached hereto and forming part hereof, which property is more particularly described as part of Parcel 4838 W&F being Part of Lot 14 Concession 1 in the former Township of Widdifield, shown as hatched on Schedule "B" attached hereto and forming part hereof from a "Heavy Industrial (M.4)" Zone and a "Rural (A)" Zone to a "Rural Extractive Industrial (RME)" Zone and a "Restricted Industrial (M.5)" Zone.
2. All buildings and structures erected or altered and the use of land in such "Restricted Industrial (M.5)" Zone and "Rural Extractive Industrial (RME)" Zone shall conform to all applicable provisions of By-Law No. 28-80 of The Corporation of the City of North Bay.
3. By-Law No. 126-82 is hereby repealed.
4. This By-law shall take effect from the date of passing by Council, and shall come into force upon the approval of The Ontario Municipal Board.

READ A FIRST TIME IN OPEN COUNCIL THE 28th DAY OF June, 1982
READ A SECOND TIME IN OPEN COUNCIL THE 12th DAY OF July, 1982
READ A THIRD TIME IN OPEN COUNCIL AND FINALLY ENACTED AND PASSED
THIS 12th DAY OF July, 1982.

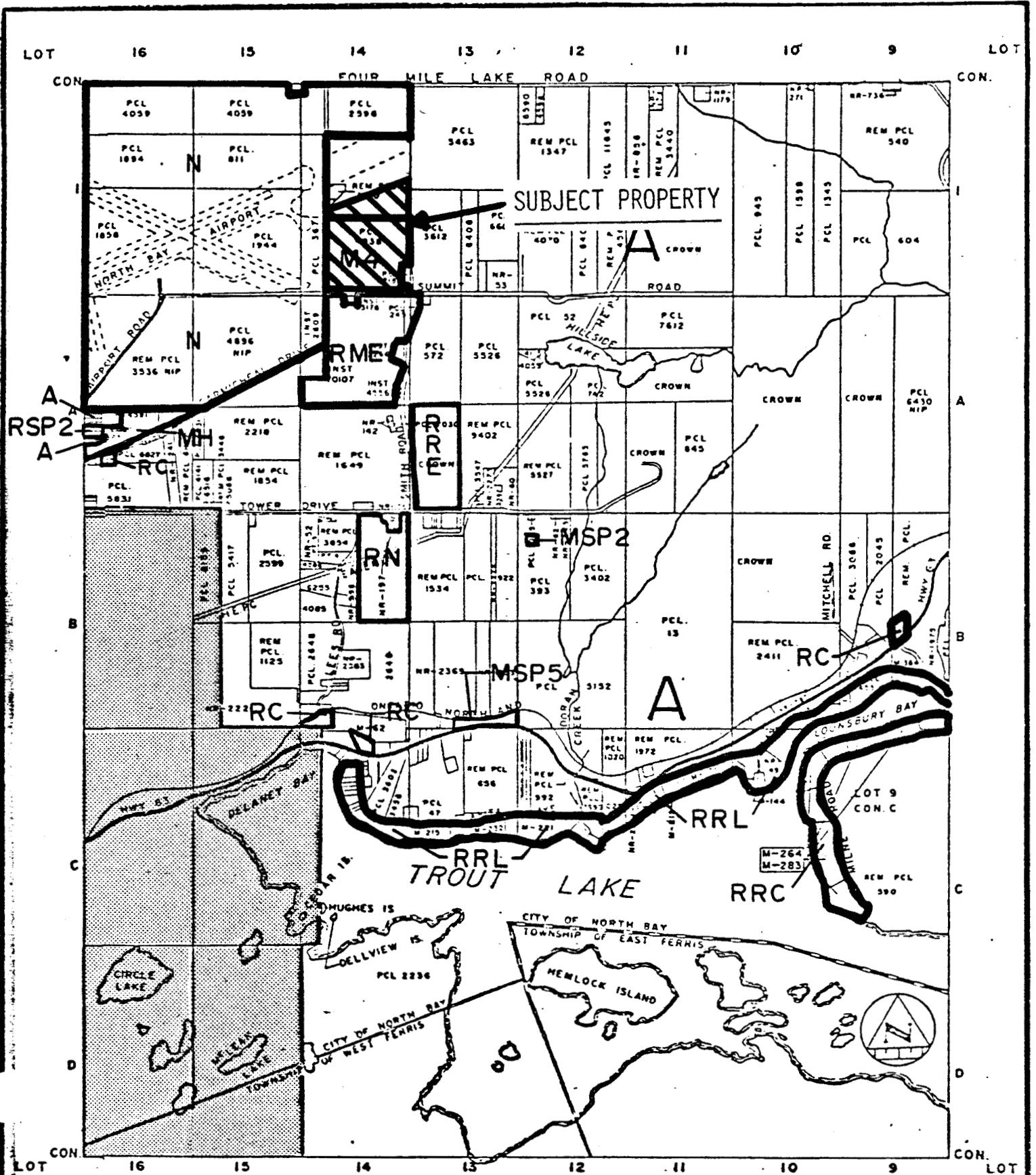

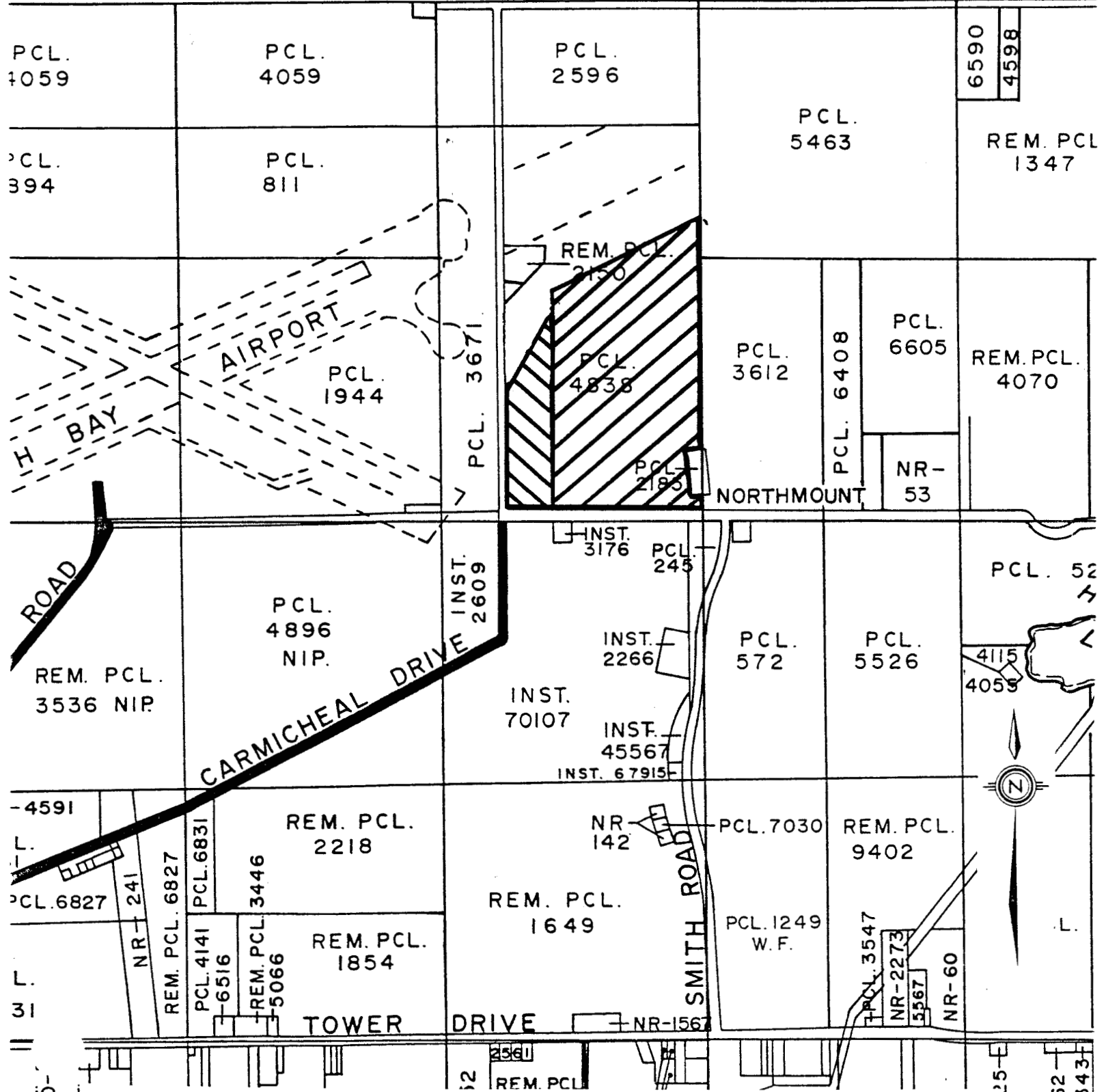
