The Corporation of the City of North Bay

By-Law No. 2017-55

Being a By-law to Amend the City of North Bay On-Street Parking By-law No. 2014-37.

Whereas section 9 of the *Municipal Act, 2001*, S.O. 2001, c.25, as amended, provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under that Act or any other Act;

And whereas section 10(1) of the *Municipal Act, 2001* provides that a single-tier municipality may provide any service or thing that the municipality considers necessary or desirable for the public;

And whereas section 10(2) of the *Municipal Act, 2001* provides that a single-tier municipality may pass by-laws respecting: in paragraph 5, social and environmental well-being of the municipality; in paragraph 6, health, safety and well-being of persons; in paragraph 7, services and things that the municipality is authorized to provide under section 10(1); in paragraph 8, protection of persons and property; and in paragraph 10, structures, including signs;

And whereas it is deemed expedient to regulate or prohibit certain parking on highways within the limits of the City of North Bay;

And whereas Resolution No. 2017-242(a) and Resolution No. 2017-242(b) were passed by Council at its Regular Meeting held on Tuesday June 27th, 2017 to authorize amendments to the On-Street Parking By-law No. 2014-37;

Now therefore the Council of the Corporation of the City of North Bay hereby enacts as follows:

- 1. That Part 2 Definitions, Section 2.1 to the On-Street Parking By-law No. 2014-37 is hereby amended by deleting in its entirety the definition of "Winter Months" and replacing it with "Winter Months means the period between November 1st and April 15th inclusive of each year".
- That Part 2 Definitions, Section 2.1 to the On-Street Parking By-law No. 2014-37 is hereby amended by adding the definition "Downtown Improvement Area (DIA) means the area of land within the Downtown Improvement Area Board's control as outlined in the map included in Schedule 11 of this By-law."
- 3. That Section 3.3 Parking Winter Months, to the On-Street Parking By-law No. 2014-37 is hereby amended by deleting in its entirety the following:

"3.3 (1) No person shall park a vehicle on any highway between the hours of 3:00 a.m. and 6:00 a.m. commencing on November 1 and ending on March 31, inclusive".

4. That Section 3.3 Parking Winter Months, to the On-Street Parking By-law No. 2014-37 is hereby amended by adding the following:

"3.3 (1) Commencing on November 1 and ending on April 15, inclusive, no person shall park a vehicle on any highway between the following hours: in the Downtown Improvement Area (DIA), between the hours of 3:00 a.m. and 6:30 a.m.; on any block of a highway where that block includes a cul-de-sac or dead-end, between the hours of 3:00 a.m. and 8:30 a.m.; and on any other highway or portion thereof, between the hours of 3:00 a.m. and 7:30 a.m."

5. That this By-law comes into effect upon being passed.


