BY-LAW NO. 2002-30

A BY-LAW TO AMEND BY-LAW NO. 28-80
TO REZONE CERTAIN LANDS ON SILVER
LADY LANE FROM A "RURAL RESIDENTIAL
LAKEFRONT (RRL)" ZONE TO A "RURAL (A)" ZONE
(257 SILVER LADY LANE JOHN 11. CLARK AND MARY E. CLARK)

WHEREAS the owner of the subject property has requested a rezoning;

AND WHEREAS the Council of The Corporation of the City of North Bay has ensured that adequate information has been made available to the public, and has held at least one public meeting after due notice for the purpose of informing the public of this By-law;

AND WHEREAS it is deemed desirable to amend the zone designation shown on Schedule "C6" of By-law No. 25-SO pursuant to Section 34 of the Planning Act R.S.O. 1990, as amended.

AND WHEREAS Council passed a resolution on April 22, 2002 to approve this rezoning.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- Schedule "C6" of By-law No. 2s-SO is amended by changing the zoning designation of the property shown on Schedule "A" attached hereto (which property is more particularly described as Plan M-144, Part Lot 9, Rem. Pcl. 332 W&F, Plan NR-607, Part 12) along Silver Lady Lane in the City of North Bay, shown as hatched on Schedule "B" attached hereto from a "Rural Residential Lakefront (RRL)" zone lo a "Rural (A)" zone.
- 2) All buildings or structures erected or altered and the use of land in such "Rural (A)" zone shall conform to all applicable provisions of By-law No. 28-80 of The Corporation of the City of North Bay.
- 3) Pursuant to Section 41 of the Planning Act, R.S.O. 1990 as amended, those lands shown as hatched on Schedule "C" attached hereto are hereby designated as a Site Plan Control Area.
- 4) a) Notice of this By-law shall be given by the Clerk in the manner and form and to the persons prescribed by Section 4 of O. Reg. 200/96 as amended.
 - Where no notice of appeal is filed with the Clerk of The Corporation of the City of North Bay within twenty (20) days after the day that the giving of written notice as required by the Act is completed, then this By-law shall be deemed to have come into force on the day it was passed.

where one or more notices of appeal arc filed with the Clerk of The Corporation of the City of North Bay within twenty (20) days after the day that the giving of written notice as required by the Act is completed, setting out the objection to the By-law and the reasons in support of the objection, then this By-law shall not come into force until all appeals have been finally disposed of, whereupon the By-law shall be deemed to have come into force on the day it was passed.

READ A FIRST TIME IN OPEN COUNCIL THE 22ND DAY OF APRIL 2002.

READ A SECOND TIME IN OPEN COUNCIL THE 23RD DAY OF SEPTEMBER 2002.

READ A THIRD TIME IN OPEN COUNCIL AND PASSED THIS 23RD DAY OF SEPTEMBER 2002.
