The Corporation of the City of North Bay

By-Law No. 2019-67

Being a By-law to Amend the City of North Bay On-Street Parking By-law No. 2014-37.

Whereas section 9 of the *Municipal Act, 2001*, S.O. 2001, c.25, as amended, provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under that Act or any other Act;

And whereas section 10(1) of the *Municipal Act, 2001* provides that a single-tier municipality may provide any service or thing that the municipality considers necessary or desirable for the public;

And whereas section 10(2) of the *Municipal Act, 2001* provides that a single-tier municipality may pass by-laws respecting: in paragraph 5, social and environmental well-being of the municipality; in paragraph 6, health, safety and well-being of persons; in paragraph 7, services and things that the municipality is authorized to provide under section 10(1); in paragraph 8, protection of persons and property; and in paragraph 10, structures, including signs;

And whereas it is deemed expedient to regulate or prohibit certain parking on highways within the limits of the City of North Bay;

And whereas Resolution No. 2019-183 was passed by Council at its Regular Meeting held on Tuesday May 7th, 2019 to authorize amendments to the On-Street Parking By-law No. 2014-37;

Now therefore the Council of the Corporation of the City of North Bay hereby enacts as follows:

- 1. That Schedule 1 to the On-Street Parking By-law No. 2014-37 is hereby amended by deleting the School Bus Loading Zone located on Second Avenue.
- 2. That Schedule 2 to the On-Street Parking By-law No. 2014-37 is hereby amended by deleting the following:
 - "Fraser Street, East side, between 34 metres north of Main Street and 48 metres north of Main Street", and
 - "Main Street, South side, between 38 metres west of Wyld Street and 26 metres west of Wyld Street".
- 3. That Schedule 2 to the On-Street Parking By-law No. 2014-37 is hereby amended by adding the following:
 - "Main Street, South side, between 85 metres east of Ferguson Street and 100 metres east of Ferguson Street", and
 - "Worthington Street East, South side, between 12 metres east of Ferguson Street and 30 metres east of Ferguson Street".
- 4. That Schedule 4 to the On-Street Parking By-law No. 2014-37 is hereby amended by deleting the following:
 - "Aubrey Street, South side, from Cassells Street to High Street", and
 - "Olive Street, South side, from High Street to Cassells Street".

- 5. That Schedule 4 to the On-Street Parking By-law No. 2014-37 is hereby amended by adding the following:
 - "Oakwood Avenue, North side, from Clarence Street to Burns Street", and
 - "Leonard Avenue, North side, from a point 85 metres east of Champlain Street to a point 93 metres east of Champlain Street", and
 - "Algonquin Avenue, East side, from a point 26 metres north of Main Street to a point 36 metres north of Main Street", and
 - "McKeown Avenue, North side, from Milani Road to Stockdale Road", and
 - "Olive Street, North side, from High Street to Cassells Street", and
 - "Aviation Avenue, South side, from Aviation Lane to a point 65 metres west of Aviation Lane", and
 - "Aviation Lane, North side, from Airport Way to Aviation Avenue", and
 - "Aviation Lane, South side, from Airport Way to a point 70 metres west of Airport Way", and
 - "Airport Way, Both sides, from Airport Road to Aviation Lane".
- 6. That Schedule 5 to the On-Street Parking By-law No. 2014-37 is hereby amended by adding the following:
 - "Ashdale Crescent, Odd side, from Booth Road to Bunting Drive", and
 - "Scollard Street, North side, from Algonquin Avenue to Browning Street", and
 - "Lavery Street, North side, from Algonquin Avenue to Browning Street", and
 - "Vimy Street, North side, from Algonquin Avenue to Browning Street".
- 7. That Schedule 6 to the On-Street Parking By-law No. 2014-37 is hereby amended by adding the following:
 - "Chippewa Street West, South side, From a point 40 metres north of Ferguson Street to a point 90 metres north of Ferguson Street, 15 minutes", and
 - "Second Avenue West, North side, From a point 30 metres west of Commercial Street to a point 60 metres west of Commercial Street, 15 minutes".
- 8. That Schedule 7 to the On-Street Parking By-law No. 2014-37 is hereby amended by adding the following:
 - "Dane Avenue, North side, between Chapais Street and Carruthers Street, from 8am to 5pm Monday to Friday inclusive".
- 9. That this By-law comes into effect upon being passed.
