BY-LAW NO. 2008-167

A BY-LAW TO AMEND ZONING BY-LAW NO. 28-80 TO REZONE CERTAIN LANDS ON MCLAREN STREET FROM A "RESIDENTIAL FIRST DENSITY (R1)" ZONE TO A "RESIDENTIAL SECOND DENSITY SPECIAL ZONE NO. 115 (R2 SP. 115)"

(MCLAREN STREET – THE SISTERS OF ST. JOSEPH OF THE DIOCESE OF SAULT STE MARIE)

WHEREAS the owner of the subject property has initiated an amendment to the Zoning By-law;

AND WHEREAS the Council of The Corporation of the City of North Bay has ensured that adequate information has been made available to the public, and has held at least one public meeting after due notice for the purpose of informing the public of this By-law;

AND WHEREAS it is deemed desirable to amend the zone designation shown on Schedule "B-42" of By-law No. 28-80 pursuant to Section 34 of the Planning Act R.S.O. 1990, as amended.

AND WHEREAS Council passed a resolution on July 21, 2008 to approve this rezoning.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- Schedule "B-42" of By-law No. 28-80 is amended by changing the zoning designation of the property shown on Schedule "A" attached hereto (which property is more particularly described as Parts 24 & 25, Lots A, B and C, Plan 36R-11867 in the Former Township of Widdifield in the City of North Bay), shown as hatched on Schedule "B" attached hereto from a "Residential First Density (R1)" to a "Residential Second Density Special No. 115 (R2 Sp.115)" zone.
- 2) All buildings or structures erected or altered and the use of land in such "Residential Second Density Special No. 115 (R2 Sp.115)" zone shall conform to all applicable provisions of Bylaw No. 28-80 of the Corporation of the City of North Bay.
- 3) Section 11 of By-law No. 28-80 is amended by inserting at the end thereof the following Section 11.2.115:
 - "11.2.115 Residential Second Density Special Zone No. 115 (R2 Sp. 115)
 - 11.2.115.1 The property description of this "Residential Second Density Special No. 115

 (R2 Sp.115)" zone is: Parts 24 & 25, Lots A, B and C, Plan 36R-11867 in the Former Township of Widdifield in the City of North Bay as shown on the attached Schedules and Schedule "B-42"

- 11.2.115.2 The minimum lot area for "Residential Second Density Special No. 115 (R2 Sp.115)" zone is 458 square metres.
- 11.2.115.3 The use of land or buildings in this "Residential Second Density Special No.

 115 (R2 Sp.115)" zone shall conform to all other regulations of this By-law,
 except as hereby expressly varied.
- Section 11 of By-law No. 28-80 is further amended by inserting Schedule to "Residential Second Density Special Zone No. 115 (R2 Sp. 115)" as shown on Schedule "C" to this By-law.
- 5) a) Notice of this By-law shall be given by the Clerk in the manner and form and to the persons prescribed by Section 4 of O. Reg. 545/06 as amended.
 - b) Where no notice of appeal is filed with the Clerk of The Corporation of the City of North Bay within twenty (20) days after the day that the giving of written notice as required by the Act is completed, then this By-law shall be deemed to have come into force on the day it was passed.
 - c) Where one or more notices of appeal are filed with the Clerk of The Corporation of the City of North Bay within twenty (20) days after the day that the giving of written notice as required by the Act is completed, setting out the objection to the By-law and the reasons in support of the objection, then this By-law shall not come into force until all appeals have been finally disposed of, whereupon the By-law shall be deemed to have come into force on the day it was passed.




