

BY-LAW NO. 97-82

BEING A BY-LAW TO AMEND BY-LAW NO. 28-80
TO REZONE CERTAIN LANDS ON FIRST AVENUE
FROM RM-1 TO COMMERCIAL SPECIAL ZONE NO. 9
(N. DELFINO)

WHEREAS upon the request of the property owner concerned and with the approval of the local Planning Board, it is considered advisable to amend By-Law No. 28-80 of The Corporation of the City of North Bay to amend the zone designation shown on Schedule "C-6" of By-Law No. 28-80 pursuant to Section 39 of The Planning Act, R.S.O. 1980, Chapter 379;

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:


1. Schedule "B-42" of said By-Law No. 28-80 is amended by changing the zoning designation of the property shown on Schedule "A" attached hereto and forming part hereof, which property is more particularly described as the westerly portion of Lot 681, Plan 21 in the City of North Bay, shown as hatched on Schedule "B" attached hereto and forming part hereof, from a "Residential Multiple First Density (RM-1)" Zone to a "Commercial Special No. 9 (C.Sp.No. 9)" Zone.
2. No building or structure shall be erected or altered and no land shall be used in said "Commercial Special No. 9 (C.Sp.No. 9)" Zone except for the following uses and in conformity with the following regulations:
 - (i) PERMITTED USES: Convenience Store
 - (ii) REGULATIONS:
 - (a) Maximum lot coverage is twenty-five percent (25%);
 - (b) Minimum front yard setback is eleven and five-tenths (11.5) metres;
 - (c) Minimum interior side yard setback is one and five-tenths (1.5) metres;
 - (d) Minimum side yard setback where a side lot line abuts a street is three (3.0) metres;
 - (e) Minimum rear yard setback is one and five-tenths (1.5) metres;
 - (f) Minimum number of on-site parking spaces is three (3).
3. All buildings or structures erected or altered and the use of land in such "Commercial Special No. 9 (C.Sp.No. 9)" Zone hereby established shall conform to all applicable provisions of By-Law No. 28-80 of The Corporation of the City of North Bay, except as hereby expressly varied.

4. By-Law No. 96-82 is hereby repealed.
5. This By-law shall take effect from the date of passing by Council, and shall come into force upon the approval of the Ontario Municipal Board.

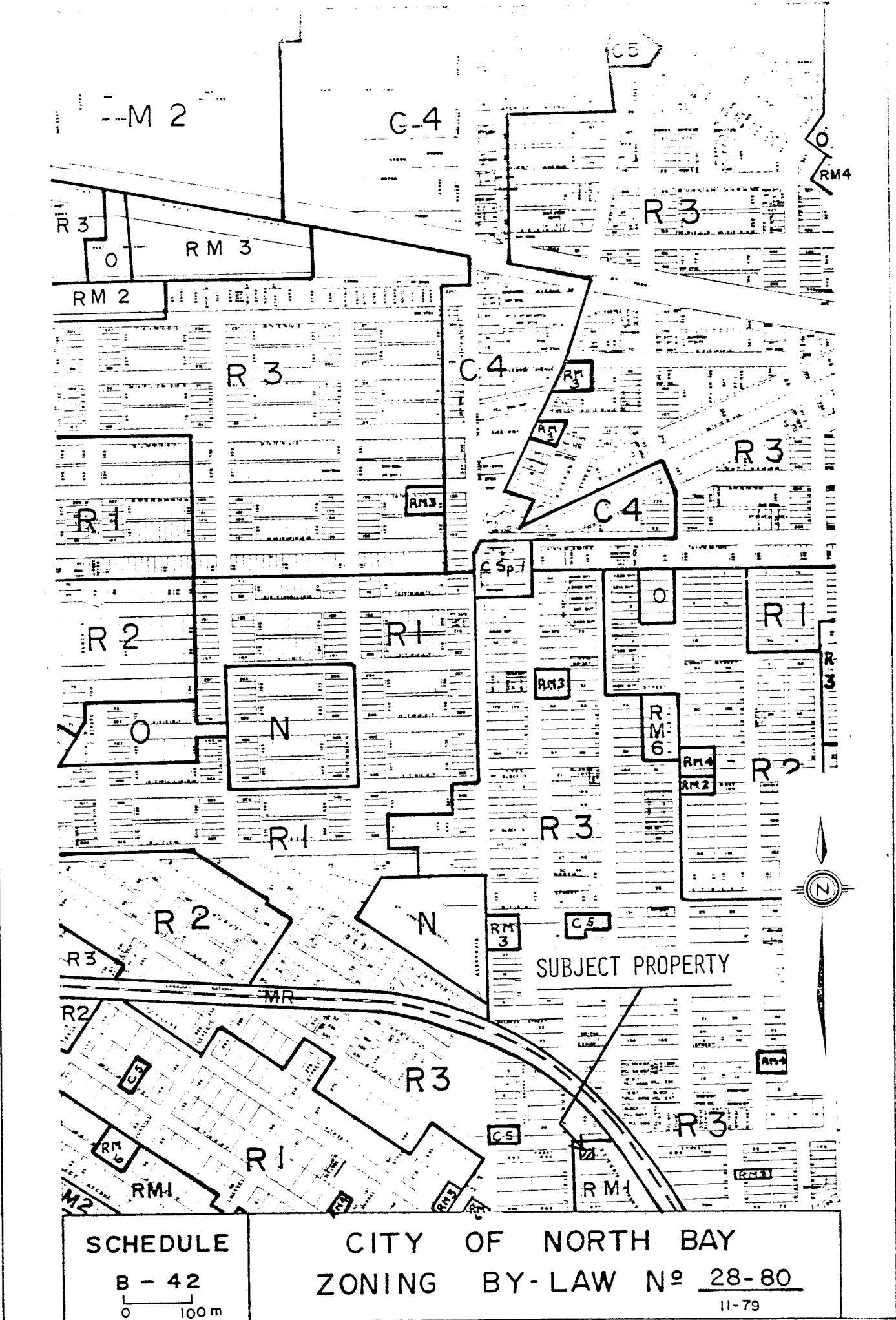
