### The Corporation of the City of North Bay

#### By-Law No. 2021-102

## Being a By-Law to Amend By-Law No. 2010-108, as amended, (Waste Management By-Law)

Whereas The Corporation of the City of North Bay (the "City") is the owner and operator of the Merrick Landfill Site located in Merrick Township (the "Landfill Site");

And Whereas the City is authorized to regulate and inspect the use of any land or structures within the municipality or any defined area or areas thereof for dumping or disposing of garbage, refuse, or domestic or industrial waste of any kind;

And Whereas the Council deems it desirable to regulate the disposal of garbage by way of landfill bans, recycling and home composting systems;

And Whereas Council passed Resolution No. 2021-335 at its Regular Meeting held on Tuesday, September 7<sup>th</sup>, 2021, to reduce the number of receptacles of waste at the curb beginning January 1, 2022;

And Whereas the City is authorized to enact by-laws imposing fees or charges for services or activities provided or done by or on behalf of it pursuant to section 391 of the *Municipal Act*, 2001 (S.O. 2001, c.25);

And Whereas Notice of the Public Meeting in the matter of the fees charged in the Waste Management By-Law was given by way of a Notice on the City of North Bay's website pursuant to City of North Bay Notice By-Law 2020-79 on 20<sup>th</sup> day of October, 2021;

And Whereas a Public Meeting under the *Municipal Act*, 2001, as amended, in the matter of the fees charged in the Waste Management By-Law was held on November 3, 2021;

And Whereas Council approved the amendments to the Waste Management By-Law by General Government Committee Report No. 2021-11 passed on the 16<sup>th</sup> day of November, 2021;

Now Therefore the Council of the Corporation of the City of North Bay hereby enacts as follows:

- 1. That Section 1 Definitions be amended to include:
  - "(f) "Receptacle (Bag) Tag" means purchasable municipal identification tag that labels refuse that is in excess of the curbside limit. A receptacle tag must be clearly visible for collectors. A tagged bag may be placed within a residential waste container."
- 2. That paragraphs 2(a) and 2(b) in Section 4 Curbside Collection of Solid Waste be deleted the following inserted in lieu thereof:
  - "(2) (a) The total number of containers placed at curbside for the collection of solid waste shall not exceed two (2) per week from each self-contained dwelling unit
  - (2) (b) The total number of containers placed at curbside for the collection of solid waste from non-residential premises shall not exceed five (5) containers twice per week."

3.	That a new Schedule "E" – Waste Collection Fees be included in the By-Law.	
4.	This By-Law comes into force and effec	t as of January 1, 2022.

### **WASTE COLLECTION FEES**

The City of North Bay shall charge the following fees:

1. Receptacle (Bag) Tag: \$2.00
