

THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 2001-140

**BEING A BY-LAW TO AMEND BY-LAW NO.
201-90, AS AMENDED BEING A BY-LAW TO
PROHIBIT UNAUTHORIZED PARKING
ON PRIVATE OR MUNICIPAL PROPERTY**

WHEREAS Section 210, subsection 124 of the Municipal Act, R.S.O. 1990, Chapter M-45, provides that by-laws may be passed by the Council of a municipality for prohibiting the parking or leaving of motor vehicles on private or municipal property;

AND WHEREAS it is deemed desirable to include the two public airport parking areas in By-law No. 201-90;

AND WHEREAS Council passed Resolution No. 2001-704 at its meeting held November 5, 2001, directing the two parking lots be included in the Private Property Parking By-law;

NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. That Clause No. 1 of By-law No. 201-90 be amended to include the following definition:
 - (e) "Parking Machine" means an automatic or other electronic, electro-mechanical or mechanical device, with the necessary standard for the device, for the purpose of controlling and regulating the parking of any vehicle in a parking space and which, when a coin, bank note or credit card has been inserted into the parking machine and the machine activated, issues a receipt indicating the date and time of that activating and the duration of the parking in or on the parking space permitted."
2. That Schedule "A" to By-law No. 201-90 be deleted therefrom and the following Schedule "A" attached hereto and forming part of this by-law be inserted in lieu thereof.
3. This by-law comes into force upon passing.



LEGAL DESCRIPTION OF PARKING AREAS TO BE REGULATED:

1. CANADORE HELIPORT

- FIRSTLY: The Remainder of Parcel 3600 in the Register for Widdifield and Ferris;
- SECONDLY: The Whole of Parcel 6844 in the Register for Widdifield and Ferris;
- THIRDLY: The Whole of Parcel 6917 in the Register for Widdifield and Ferris;
- FOURTHLY: ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the Township of Widdifield in the District of Nipissing and Province of Ontario and being composed of part of the west Half of Lot 21, Concession V in the said Townshsip.

2. COMMERCE COURT CAMPUS

- FIRSTLY: Block "L" in the said Township of Widdifield now City of North Bay, as shown on Plan M-455 registered in the Office of Land Titles at North Bay;
- SECONDLY: Block "Q" in the said Township of Widdifield now City of North Bay, as shown on Plan M-455 registered in the Office of Land Titles at North Bay;
- THIRDLY: Part of Block "A" in the said Township of Widdifield now City of North Bay, as shown on Plan M-455 registered in the Office of Land Titles at North Bay, said Part shown on a plan of survey recorded in the said Land Titles Office as Plan 36R-3508 and designated thereon as Part 1;
- FOURTHLY: Part of Block B, in the said Township of Widdifield, now City of North Bay, as shown on Plan M-455 registered in the Office of Land Titles at North Bay, said Part shown on a plan of survey recorded in the said Land Titles Office as Plan 36R-3508 and designated thereon as Part 2.

Being the Whole of Parcel 12450 in the Register for Widdifield and Ferris, in the District of Nipissing.
