BY-LAW NO. 2004-21

**BEING A BY-LAW TO AMEND TRAFFIC & PARKING BY-LAW NO. 2002-001
SECTION 12 (LOADING ZONES);
SECTION 18 (NO PARKING AT ANY TIME) AND
SECTION 20 (NO PARKING AREAS RESTRICTED TIMES)**

WHEREAS the *Municipal Act, 2001*, (S.O. 2001, c.25) authorizes the Council to pass By-laws regulating or prohibiting certain traffic on highways and regulating or prohibiting parking on highways;

AND WHEREAS the *Highway Traffic Act*, R.S.O. 1990, Chapter H-8, as amended, authorizes the Council to pass By-laws regulating traffic on highways;

AND WHEREAS the amendments to Section 12 (Loading Zones), Section 18 (No Parking At Any Time) and Section 20 (No Parking Areas Restricted Times) were authorized by Resolution No. 2004-07, passed by Council at its Regular Meeting held on Monday, January 12, 2004;

NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. That Schedule 12 to Traffic & Parking By-law No. 2002-001 is hereby amended by deleting the following:

	<u>ROAD</u>	<u>SIDE</u>	<u>BETWEEN</u>
21.	Oak Street	North	39 metres west of Fisher Street and 59 metres west of Fisher Street"

2. That Schedule 12 to Traffic & Parking By-law No. 2002-001 is hereby amended by adding the following:

	<u>ROAD</u>	<u>SIDE</u>	<u>BETWEEN</u>
21.	Oak Street	North	39 metres west of Fisher Street and 67 metres west of Fisher Street"

3. That Schedule 18 to Traffic & Parking By-law No. 2002-001 is hereby amended by adding the following:

<u>SECTION O</u>			
<u>ROAD</u>	<u>SIDE</u>	<u>FROM</u>	<u>TO</u>
Oak Street	North	67 metres west of Fisher Street	90 metres west of Fisher Street"

4. That Schedule 20 to Traffic & Parking By-law No. 2002-001 is hereby amended by adding the following:

<u>ROAD</u>	<u>SIDE</u>	<u>BETWEEN</u>	<u>PERIOD OF TIME</u>
Oak Street	North	90 metres and 110 metres west of Fisher Street	30 minute time"

5. That this by-law comes into effect upon being passed.

READ A SECOND TIME IN OPEN COUNCIL THIS 26TH DAY OF JANUARY, 2004.
