

THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 22-91

BEING A BY-LAW TO AMEND BY-LAW 201-90 REGARDING
UNAUTHORIZED PARKING ON PRIVATE OR MUNICIPAL
PROPERTY.

WHEREAS it is deemed desirable to amend By-law 201-90
to authorize the City Clerk to appoint municipal officers for the
purpose of enforcing By-law 201-90 on private lands;

AND WHEREAS it is deemed desirable to amend By-law
201-90 to add the College Education Centre Campus to those
private lands.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH
BAY HEREBY ENACTS AS FOLLOWS:

1. (a) Schedule "A" to By-law 201-90 is hereby amended by
adding the following Section 1.1 thereto:

"1.1 College Education Centre Campus, College Drive
that part of Lot 23, Concession B designated as
all of Parcel 3347 W & F."

- (b) Schedule "A" to By-law 201-90 is hereby amended by
adding the following section 4 thereto:

"4. Northgate Square, 1500 Fisher Street, being Part
1, Plan 36R-5135, Parts 1, 2, 3 Plan 36R-5419,
Parts 1 to 9, Plan 36R-5084."

2. Paragraph (iv) of section 12 of By-law 201-90 is hereby
deleted and the following paragraph inserted in lieu
thereof:

"(iv) Those persons who are employed by the owners
of the lands described on Schedule "A" hereto
who have been appointed in writing by the City
Clerk as municipal officers for the purpose of
enforcing the terms of this by-law, only:

(i) While such person is employed by the owner of the lands described in Schedule "A";

(ii) Whose appointment hereunder as a municipal officer has not been suspended or revoked by the City Clerk."

3. Section 12 of By-law 201-90 is hereby amended to identify the existing section 12 as paragraph (1) and to add the following paragraph "2":

"(2) (a) The City Clerk is hereby authorized to appoint individuals as municipal officers for the purpose of enforcing the terms of this by-law, who comply with the terms of section 11 hereof.

(b) The City Clerk is hereby authorized to suspend or revoke the appointment of any person hereunder as a municipal officer subject to the terms of the Statutory Powers Procedures Act."

4. Schedule "C" to By-law 201-90 is hereby repealed.

READ A FIRST TIME IN OPEN COUNCIL THE 4th DAY OF FEBRUARY, 1991.

READ A SECOND TIME IN OPEN COUNCIL THE 18TH DAY OF FEBRUARY, 1991.

READ A THIRD TIME IN OPEN COUNCIL AND FINALLY ENACTED AND PASSED THIS 18TH DAY OF FEBRUARY, 1991.
