BY-LAW NO. 2007-11

BEING A BY-LAW TO AMEND TRAFFIC & PARKING BY-LAW NO. 2002-001 SCHEDULE 5 (DESIGNATED THROUGH HIGHWAYS – SECTION 10) SCHEDULE 6 (STOP SIGNS – SECTION 11) AND SCHEDULE 18 (NO PARKING AREAS AT ANY TIMES – SECTION 28)

WHEREAS the Municipal Act, 2001, (S.O. 2001, c.25) authorizes the Council to pass By-Laws regulating or prohibiting certain traffic on highways and regulating or prohibiting parking on highways;

AND WHEREAS the *Highway Traffic Act*, R.S.O. 1990, Chapter H-8, as amended, authorizes the Council to pass By-laws regulating traffic on highways;

AND WHEREAS the amendment to Schedule 5 (Designated Through Highways – Section 10) was authorized by Resolution No. 2007-41 passed by Council at its Regular Meeting held on Monday, January 22, 2007;

AND WHEREAS the amendment to Schedule 6 (Stop Signs – Section 11) was authorized by Resolution No. 2007-33 passed by Council at its Regular Meeting held on Monday, January 22, 2007;

AND WHEREAS the amendment to Schedule 18 (No Parking Areas At Any Time – Section 28) was authorized by Resolution No. 2007-33 passed by Council at its Regular Meeting held on Monday, January 22, 2007;

NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. That Schedule 5 to Traffic & Parking By-Law No. 2002-001 is hereby amended by deleting the following:

2. That Schedule 6 to Traffic & Parking By-Law No. 2002-001 is hereby amended by adding the following:

"Janey Avenue and Vermont Crescent

On all three approaches"

3. That Schedule 18 to Traffic & Parking By-Law No. 2002-001 is hereby amended by adding the following:

SECTION J "Janey Avenue	Both	200 m East of Greenhill Avenue	Vermont Crescent"

4. That this by-law comes into effect upon being passed.
