That 1) the interim financing agreement with the North Bay-Mattawa Conservation Authority authorized by By-Law No. 1999-25 be amended to provide for the following:

- that the Director of Financial Services be authorized to advance by way of loan, an additional \$850,000 to the North Bay-Mattawa Conservation Authority, subject to the application of \$200,000 thereof to its existing accounts receivable account with the City;
- b) that the loan payment schedule be extended to include 13 payments of \$65,000.00 due December 1, 2004 to April 1, 2005 and December 1, 2005 to April 1, 2006 and December 1, 2006 to February 1, 2007;
- c) that the terms of the agreement be amended to make any outstanding principal and/or interest to become due and payable on March 1, 2007 instead of March 1, 2004; and
- 2) Council acknowledge the North Bay-Mattawa Conservation Authority's current accumulated deficit of about \$2,4000,000 and therefore imposes the following conditions, being:
 - a) under the direction of the City Treasurer, a Deficit Reduction Plan and Budget Control Plan be developed for presentation to Council by no later than March 31, 2003;
 - b) that the City Treasurer work with the North Bay-Mattawa Conservation Authority to develop a financial reporting format, to be used subject to Council's approval, to include all operating budgets and current capital projects, by no later than March 31, 2003;
 - that the conditions for approval be included in the amending agreement; and

d) that the City Solicitor and the City Treasurer be authorized and directed to advance the additional amount of \$850,000 upon receipt of the North Bay-Mattawa Conservation Authority's acceptance and agreement, by resolution, to enter into an amending agreement including the above conditions.
