Your Worship and Councillors:

The General Government Committee presents Report No. 2003-08 and recommends:

1. That the 2003 Operating Budget in the amount of \$82,523,099 (excluding water and sanitary sewer expenditures in the amount of \$10,081,200) with a resultant tax levy of \$48,875,199 be approved. **(Schedule A)**
2. That budget adjustments summarized on the attached **Schedule B**, resulting in a net increase in the tax levy totaling \$109,639 from the Status Quo Operating Budget, be included in the Operating Budget.
3. That the Director of Financial Services be authorized to process all transfers to and from Reserve Funds included in the Operating Budget.
4. That \$300,000 be included in the Operating Budget for special labor contingencies and the Director of Financial Services be authorized to transfer up to this amount to the appropriate labor budgets based upon collective agreements.
5. That the levies of all Agencies, Boards and Commissions totaling \$32,758,223 as summarized on the attached **Schedule C** be included in the tax levy.
6. That the Director of Financial Services be authorized to transfer \$4,364,400 from the Operating Fund to the Capital Fund to finance approved capital projects that would otherwise require debenture issuance to fund. (Net Capital Levy in Operating Budget).
7. That the tax rates included on **Schedule D** be adopted for the 2003 taxation year, subject to confirmation of the education rates from the Province.
8. That the due date for the property tax installment be set at June 30 for the 2003 taxation year.
9. That the following tax policy positions be adopted for the 2003 taxation year.
 - a) All tax policy positions adopted in 2002 except as amended below
 - b) That the tax ratio for the farm property class be lowered to 0.15
 - c) That the tax ratio for the industrial class be lowered to 1.40
10. That an amended Long-Term Capital Funding Policy be adopted as presented on **Schedule E**.

11. a) That the 2003 Capital Budget in the amount of \$11,003,250 summarized as follows:

BE IT THEREFORE RESOLVED THAT staff be instructed to prepare a report investigating the merits of installation of this technology on existing septic systems on Trout Lake, this to include costs/enforcement/special

area charges to absorb initial costs and to include the cost options to extend City services to Anita Avenue and Silver Lady Lane, with said report to be provided prior to June 30, 2003.
