

The Corporation of the City of North Bay

By-Law No. 2024-06

**Being a By-Law to Amend By-Law No. 2010-108, as amended,
(Waste Management By-Law – Schedule “A”)**

Whereas The Corporation of the City of North Bay (the “City”) is the owner and operator of the Merrick Landfill Site located in Merrick Township (the “Landfill Site”);

And Whereas the City is authorized to enact by-laws imposing fees or charges for services or activities provided or done by or on behalf of it pursuant to section 391 of the *Municipal Act, 2001* (S.O. 2001, c.25);

And Whereas the City is authorized to regulate and inspect the use of any land or structures within the municipality or any defined area or areas thereof for dumping or disposing of garbage, refuse, or domestic or industrial waste of any kind;

And Whereas the Council deems it desirable to regulate the disposal of garbage by way of landfill bans, recycling and home composting systems;

And Whereas Notice of the Public Meeting in the matter of waste management fees and charges was given in accordance with City of North Bay Notice By-Law 2020-79, by publishing the notice, 14 days in advance of the public meeting, in the Public Notice section of the City of North Bay’s website on Wednesday, December 13th, 2023.

And Whereas a Public Meeting under the *Municipal Act* in the matter of the waste management fees and charges was held on the 15th day of January, 2024;

And Whereas by General Government Committee Report No. 2024- passed at its Regular Meeting held on Tuesday, January 30, 2024 Council authorize a by-law to increase the current fees and charges in place for waste management.

Now Therefore the Council of the Corporation of the City of North Bay hereby enacts as follows:

1. Schedule “A” of By-Law No. 2010-108, as amended, is hereby further amended as follows:

“Classifications	Effective Date
Waste	April 1, 2024
a) Solid waste from industrial, commercial and institutional sources	\$110.00/tonne (\$20.00 load minimum
h) All private vehicles, solid waste in small quantities (equivalent to 6 bags or less)	\$10.00
i) All private vehicles, solid waste in small quantities exceeding 6 bags	\$25.00

Mixed Load

- u) Commercial or Weighed Loads \$220.00 per metric tonne
- v) All private vehicles, solid waste in small quantities (6 bags or less) \$20.00 per load
- w) All private vehicles with quantities (exceeding 6 bags) \$50.00 per load

2. This By-Law comes into force and effect on April 1, 2024.
