BY-LAW NO. 62-91

BEING A BY-LAW TO AMEND BY-LAW NO. 201-90 BEING A BY-LAW TO PROHIBIT UNAUTHORIZED PARKING ON PRIVATE OR MUNICIPAL PROPERTY

WHEREAS the Council of The Corporation of the City of North Bay deems it advisable to amend the By-law relating to unauthorized parking on private property.

NOW THEREFORE THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1. By-law 201-90 is hereby amended by placing the subtitle of "Park Without Consent" below section 1 (e) and by placing the numeral "2" opposite the section after section 1 (e).
- 2. That Clause No. 13 (b) of By-law No. 201-90 be deleted therefrom and the following Clause 13 (b) inserted in lieu thereof:
 - "13. (b) Any person who contravenes any provision of this bylaw is guilty of an offence and subject to a fine recoverable under the Provincial Offences Act."
- 3. That By-law No. 201-90 be further amended by deleting Schedule "B" therefrom and inserting in lieu thereof Schedule "B" attached hereto and forming part of this By-law.
- 4. This by-law shall come into effect as of the date of the Order of the Chief Justice of the Ontario Court of Justice (Provincial Division) to establish the set fines for the offences set out on Schedule "B" hereto.
