

**THE CORPORATION OF THE CITY OF NORTH BAY**

**BY-LAW NO. 2007-22**

**BEING A BY-LAW TO AMEND TRAFFIC & PARKING BY-LAW NO. 2002-001  
SCHEDULE 18 (NO PARKING AT ANY TIME – SECTION 28) AND  
SCHEDULE 20 (NO PARKING AREAS RESTRICTED TIMES – SECTION 30)**

**WHEREAS** the *Municipal Act, 2001*, (S.O. 2001, c.25) authorizes the Council to pass By-Laws regulating or prohibiting certain traffic on highways and regulating or prohibiting parking on highways;

**AND WHEREAS** the *Highway Traffic Act*, R.S.O. 1990, Chapter H-8, as amended, authorizes the Council to pass By-laws regulating traffic on highways;

**AND WHEREAS** the amendment to Schedule 18 (No Parking At Any Time – Section 28) and Schedule 20 (No Parking Areas Restricted Times – Section 30) were authorized by Resolution No. 2007-73 passed by Council at its Regular Meeting held on Monday, February 5, 2007;

**NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:**

1. That Schedule 18 (No Parking At Any Time- Section 28) to Traffic & Parking By-Law No. 2002-001 is hereby amended by adding the following:

<u>"Road</u> <b>SECTION M</b>	<u>Side</u>	<u>From</u>	<u>To</u>
McIntyre Street West	North	Durrill Street	Harvey Street"

2. That Schedule 20 (No Parking Areas Restricted Times – Section 30) to Traffic & Parking By-Law No. 2002-001 is hereby amended by adding the following:

<u>"Road</u>	<u>Side</u>	<u>Between</u>	<u>Period of Time</u>
McIntyre Street West	South	Durrill Street and Harvey Street	2 hours during 8:00 a.m. to 4:00 p.m. Monday to Friday inclusive"

3. That this by-law comes into effect upon being passed.

READ A FIRST TIME IN OPEN COUNCIL THIS 5<sup>TH</sup> DAY OF MARCH, 2007.

READ A SECOND TIME IN OPEN COUNCIL THIS 5<sup>TH</sup> DAY OF MARCH, 2007.
