The Corporation of the City of North Bay

By-Law No. 2015-36

Being a By-law to Amend the City of North Bay On-Street Parking By-law No. 2014-37.

Whereas section 9 of the *Municipal Act, 2001*, S.O. 2001, c.25, as amended, provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under that Act or any other Act;

And whereas section 10(1) of the *Municipal Act, 2001* provides that a single-tier municipality may provide any service or thing that the municipality considers necessary or desirable for the public;

And whereas section 10(2) of the *Municipal Act, 2001* provides that a single-tier municipality may pass by-laws respecting: in paragraph 5, social and environmental well-being of the municipality; in paragraph 6, health, safety and well-being of persons; in paragraph 7, services and things that the municipality is authorized to provide under section 10(1); in paragraph 8, protection of persons and property; and in paragraph 10, structures, including signs;

And whereas it is deemed expedient to regulate or prohibit certain parking on highways within the limits of the City of North Bay;

Now therefore the Council of the Corporation of the City of North Bay hereby enacts as follows:

1. That Section 2.1 Definitions to the On-Street Parking By-law No. 2014-37 is hereby amended to add the following:

"Winter Months" means the period between November 1^{st} and March 31^{st} inclusive of each year.

2. That Section 2.1 Definitions to the On-Street Parking By-law No. 2014-37 is hereby amended to delete the definition of "Stand" or "Standing" in its entirety and replace it with the following:

"Stand" or "Standing" means the halting of a vehicle, whether occupied or not.

3. That Schedule 1 (School Bus Loading Zones) to the On-Street Parking By-law No. 2014-37 is hereby amended by deleting in its entirety the following:

"Gertrude Street, north side, from a point 55 metres east of the centre line of Lakeshore Drive easterly for a distance of 63 metres".

4. That Schedule 4 (No Parking Areas-Any Time) to the On-Street Parking Bylaw No. 2014-37 is hereby amended by deleting in its entirely the following:

"First Avenue, north side, from Fisher Street, to John Street", and "Johnston Road, west and north sides, from 110 metres east of Lindsay Street, to 214 Metres east of Lindsay Street", and "Memorial Drive, north side, from James Street, to Colgan Street", and "Memorial Drive, both sides, from Main Street West, to 30 Metres south of entrance to marina building/boat ramp", and "Tenth Street, both sides, from Main Street to End of Tenth Street".

5. That Schedule 4 (No Parking Areas-Any Time) to the On-Street Parking Bylaw No. 2014-37 is hereby amended by adding the following:

"First Avenue, north side, from Fisher Street, to Regina Street", and "Johnston Road, west and north sides, from 110 metres east of Lindsay Street, to 233 metres east of Lindsay Street", and

"McKeown Avenue, north side, from Stockdale Road to 1429 McKeown Avenue", and

"McKeown Avenue, south side, from 50 metres east of Mary Street to Mary Street", and

"Memorial Drive, both sides, from Main Street West, to James Avenue", and "Memorial Drive, south side, from James Avenue, to Judge Avenue", and "Memorial Drive, north side, from James Avenue, to a point 14 metres west of Colgan Avenue, and

"Memorial Drive, north side, from a point 67 metres west of Judge Avenue, to Judge Avenue", and

"Milani Road, north side, from 1429 McKeown Avenue to 174 Milani Road", and

"Milani Road, south side, from Mary Street to 174 Milani Road", and "Sherbrooke Street, west side, from First Avenue to Second Avenue".

6. That Schedule 6 (Maximum Parking Times) to the On-Street Parking By-law No. 2014-37 is hereby amended by adding the following:

"McIntyre Street West, south side, between Murray Street and Harvey Street, 2 hours during 8:00am to 4:00pm Monday to Friday inclusive".

7. That this By-law comes into effect upon being passed.
