PET SHOP

Every Person that operates a Pet Shop.
Pet Shop shall mean every shop, place, business or premise in which dogs, cats, fish, reptiles, birds or any other pet that is generally understood to be domesticated is sold or kept for sale.
The requirement to obtain a "Pet Store Licence" does not apply to: (i) An animal shelter operated on or behalf of a public authority; (ii) A veterinary hospital or clinic; or (iii) Any facility in which animals are placed for care pursuant to the Animals for Research Act, R.S.O. 1990, c.A.22, as amended.

If the North Bay and District Humane Society finds an animal that is in distress, the Licencing Officer may suspend or revoke the licence. A Licence may be revoked or suspended where an animal is sold or offered for sale where it is prohibited by Federal or
