

**THE CORPORATION OF THE CITY OF NORTH BAY**

**BY-LAW NO. 2004-20**

**BEING A BY-LAW TO AMEND TRAFFIC & PARKING BY-LAW NO. 2002-001  
SECTION 18 (NO PARKING AT ANY TIME) AND  
SECTION 19 (NO PARKING AREAS AT ANY TIME – WINTER MONTHS)**

**WHEREAS** the *Municipal Act, 2001*, (S.O. 2001, c.25) authorizes the Council to pass By-laws regulating or prohibiting certain traffic on highways and regulating or prohibiting parking on highways;

**AND WHEREAS** the *Highway Traffic Act*, R.S.O. 1990, Chapter H-8, as amended, authorizes the Council to pass By-laws regulating traffic on highways;

**AND WHEREAS** the amendments to Section 18 (No Parking At Any Time) and Section 19 (No Parking At Any Time – Winter Months) were authorized by Resolution No. 2004-11, passed by Council at its Regular Meeting held on Monday, January 12, 2004;

**NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:**

1. That Schedule 18 to Traffic & Parking By-law No. 2002-001 is hereby amended by deleting the following:

<u>SECTION W ROAD</u>	<u>SIDE</u>	<u>FROM</u>	<u>TO</u>
William Street	West	50 metres north of Preston Street	Preston Street”

2. That Schedule 18 to Traffic & Parking By-law No. 2002-001 is hereby amended by adding the following:

<u>SECTION W ROAD</u>	<u>SIDE</u>	<u>FROM</u>	<u>TO</u>
William Street	West	Preston Street	Marshall Avenue
William Street	East	57 metres north of Preston Street	107 metres north of Preston Street”

3. That Schedule 19 to Traffic & Parking By-law No. 2002-001 is hereby amended by deleting the following:

<u>SECTION W ROAD</u>	<u>SIDE</u>	<u>FROM</u>	<u>TO</u>
William Street	East	Preston Street	Marshall Avenue”

4. That Schedule 19 to Traffic & Parking By-law No. 2002-001 is hereby amended by adding the following:


<u>SECTION W ROAD</u>	<u>SIDE</u>	<u>FROM</u>	<u>TO</u>
William Street	East	Preston Street	57 metres north of Preston Street
William Street	East	107 metres north of Preston Street	Marshall Avenue”
