BY-LAW NO. 2001-142

BEING A BY-LAW TO AMEND BY-LAW NO. 114-86 BEING A BY-LAW TO DESIGNATE A FIRE ROUTE (NORTH BAY JACK GARLAND AIRPORT)

WHEREAS By-law No. 114-86 provides regulations for the designation of Fire Routes to be identified on Schedule "B" thereto;

AND WHEREAS Council has determined that a Fire Route should be designated at the North Bay Jack Garland Airport;

AND WHEREAS Council passed Resolution No. 2001-704 at its meeting held November 5,2001, to designate such a fire route;

NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

Part of the South Half of Lot 15, Concession 1, designated as Parts 5 and 7, Plan 36R-10360.

Part of the North Half of Lot 14, Concession A, Township of Widdifield designated as Part 1 on Plan 36R-10361 as previously described in Instrument No. 2609.
