BY-LAW NO. 2003-38

BEING A BY-LAW TO AMEND BY-LAW NO. 29-91 BEING A BY-LAW TO REGULATE ON AND OFF-STREET PARKING FOR DISABLED PERSONS ON McINTYRE STREET WEST IN THE CITY OF NORTH BAY FOR PHARA BUS VEHICLES ONLY (EMPIRE LIVING CENTRE)

WHEREAS Council may authorize the creation and designation of parking spaces on highways and/or municipal or private property for the exclusive use of vehicles which are displaying a permit in accordance with the requirements of the Highway Traffic Act and the regulations made thereunder;

AND WHEREAS the Council may create special parking exemptions for the drivers and the operators of vehicles which are displaying a permit in accordance with the requirements of the *Highway Traffic Act* and the regulations made thereunder and this bylaw

AND WHEREAS the Council deems it desirable to remove the designated parking space from McIntyre Street West and replacing it with restricted parking for PHARA bus vehicles only;

AND WHEREAS the restricted parking for PHARA bus vehicles only was approved by Resolution No. 2003-127 passed by Council at its Regular Meeting held on Monday, March 10,2003;

NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1. That By-law No. 29-91 be amended by adding the following paragraph to section 1:
 - (5) "PHARA bus" means a bus provided by the Physically Handicapped Adult's Rehabilitation Association.
- 2. That By-law No. 29-91 be amended by adding the following paragraph to section 4:
 - A delivery and drop off zone is hereby established with a twenty minute (5)time limit for PHARA bus vehicles only as described in Schedule V attached hereto and forming part of this by-law.
- 3. That Schedule I of By-law No. 29-91 is hereby amended by deleting therefrom the following:
