BY-LAW NO. 1999-15

BEING A BY-LAW TO AMEND BY-LAW NO. 11-95 BEING A BY-LAW TO REGULATE, GOVERN AND PROHIBIT MOTORIZED SNOW VEHICLES IN THE CITY OF NORTH BAY

WHEREAS the Motorized Snow Vehicle Act, R.S.O.1990, Chapter M-44, subsection 7(2) provides that the Council of a municipality may pass by-laws regulating, governing or prohibiting the operation of motorized snow vehicles within the municipality including any highways therein or any part or parts thereof;

AND WHEREAS the Council of the City of North Bay deems it desirable to regulate, govern and prohibit the operation of motorized snow vehicles within the municipality;

AND WHEREAS the Council desires to improve snow vehicle access to services in North Bay in a regulated fashion;

NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1. That Clause No. 2(1)(a) of By-law No. 11-95 be amended by adding the word "and" at the end of the clause so that Clause No. 2(1)(a) shall read as follows:
 - "such motorized snow vehicle is being operated for the purposes of going directly to a specific destination, and"
- 2. That Clause No. 5(1) be amended by deleting the Clause from the By-law and inserting in lieu thereof the following Clause No. 5(1):
 - "Subject to Section 8, no person shall operate a motorized snow vehicle on any sidewalk except in the areas designated on Schedule "D".
- 3. That Clause No. 10 of By-law No. 11-95 be amended by adding the following subsection:
 - (a) (iv) on any sidewalk designated on Schedule "D".
- 4. That Schedule "C" of By-law No. 11-95 be deleted and the attached Schedule "C" be inserted in lieu thereof.
- 5. That Schedule "B" of By-law No. 11-95 be deleted and the attached Schedule "B" be be inserted in lieu thereof.
- 6. That this by-law shall come into force and effect upon passing.
