The Corporation of the City of North Bay

By-Law No. 2016-41

Being a By-law to Amend the City of North Bay On-Street Parking By-law No. 2014-37

Whereas section 9 of the *Municipal Act, 2001*, S.O. 2001, c.25, as amended, provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under that Act or any other Act;

And whereas section 10(1) of the *Municipal Act, 2001* provides that a single-tier municipality may provide any service or thing that the municipality considers necessary or desirable for the public;

And whereas section 10(2) of the *Municipal Act, 2001* provides that a single-tier municipality may pass by-laws respecting: in paragraph 5, social and environmental well-being of the municipality; in paragraph 6, health, safety and well-being of persons; in paragraph 7, services and things that the municipality is authorized to provide under section 10(1); in paragraph 8, protection of persons and property; and in paragraph 10, structures, including signs;

And whereas it is deemed expedient to regulate or prohibit certain parking on highways within the limits of the City of North Bay;

And whereas Resolution No. 2016-112 was passed by Council at its Regular Meeting held on Monday, March 7, 2016 to authorize amendments to the On-Street Parking By-law No. 2014-37;

Now therefore the Council of the Corporation of the City of North Bay hereby enacts as follows:

1. That Section 3.14 Parking Meter Zones – Schedule 8 to the On-Street Parking By-law No. 2014-37 is hereby amended to add the following:

"3.14 (3) (c) or, parking payment has been purchased and confirmed through the on-line parking payment system to be current and valid for the vehicle in the location where it is parked".

2. That Section 3.14 Parking Meter Zones – Schedule 8 to the On-Street Parking By-law No. 2014-37 is hereby amended to add the following:

"3.14 (4) (a) (iii) or, no person shall park a vehicle unless parking payment has been purchased and confirmed through the on-line parking payment system to be current and valid for the vehicle in the location where it is parked."

3. That Section 3.14 Parking Meter Zones – Schedule 8 to the On-Street Parking By-law No. 2014-37 is hereby amended to add the following:

"3.14 (11) All parking at any parking meter zone as prescribed in Schedule 8 can be paid for using the on-line parking payment system. Vehicles can move from one on-street parking meter zone to another without purchasing a new on-line parking payment provided their time has not expired and the maximum time restriction for the street on which they have parked has not been exceeded as listed in Schedule 8. A vehicle must leave the street once the maximum time restriction for the street, as listed in Schedule 8 has been exceeded."

- 4. That Section 3.16 Pay-By-Phone Zones to the On-Street Parking By-law No. 2014-37 is hereby amended by adding the following:
 - "3.16 Pay-By-Phone Zones
 - (1) Pay-By-Phone zones are clearly marked by signage indicating the rate and/or maximum duration that parking is permitted within these zones, and
 - (2) No person shall park a vehicle in a Pay-By-Phone zone unless payment for parking has been purchased and confirmed through the on-line parking payment system and said payment is

current and valid for the vehicle in the location where it is parked.

- (3) Pay-By-Phone parking rates are described in Schedule 10 of this By-law."
- 5. That Schedule 4 (No Parking Areas-Any Time) to the On-Street Parking Bylaw No. 2014-37 is hereby amended by deleting in its entirety the following:

"Cedar Heights Road, north side, from a point 130 metres west of College Drive, to a point 230 metres west of College Drive".

6. That Schedule 4 (No Parking Areas-Any Time) to the On-Street Parking Bylaw No. 2014-37 is hereby amended by adding the following:

"Cedar Heights Road, north side, from a point 130 metres west of College Drive, to a point 260 metres west of College Drive", and "McIntyre Street West, south side, from Foran Street, to Plouffe Street", and "Sherbrooke Street, east side, from Worthington Street East, to a point 60 metres north of Worthington Street East".

7. That Schedule 5 (No Parking Areas-Any Time-Winter Months) to the On-Street Parking By-law No. 2014-37 is hereby amended by deleting in its entirety the following:

"Foran Street, west side, from Main Street, to McIntyre Street", and "Fraser Street, west side, from Second Avenue, to Third Avenue", and "McIntyre Street West, south side, from Foran Avenue, to Plouffe Street".

8. That Schedule 5 (No Parking Areas-Any Time-Winter Months) to the On-Street Parking By-law No. 2014-37 is hereby amended by adding the following:

"Fifth Avenue, south side, from Cassells Street, to Front Street".

9. That Schedule 8 (Parking Meter Zones) to the On-Street Parking By-law No. 2014-37 is hereby amended by adding the following:

"On-Line Parking Payment System/Pay-By-Phone:

Location: All parking meter zones, Parking Fee Per Hour: \$1.25 plus service fee, Maximum Period of Time: As per individual locations"

10.That Schedule 9 (On-Street Parking Permit Rates) to the On-Street Parking By-law No. 2014-37 is hereby amended by adding the following:

"Third Avenue, Block: 200 West, 2016:\$65.56, 2017:\$67.53"

- 11.That Schedule 10 (On-Line Parking Payment System/Pay-By-Phone Rates) to the On-Street Parking By-law No. 2014-37 is hereby added as attached.
- 12. That this By-law comes into effect upon being passed.
