BY-LAW NO. 2012-96

BEING A BY-LAW TO AMEND BY-LAW NO. 2007-89 (A BY-LAW TO REGULATE ON AND OFF STREET PARKING FOR DISABLED PERSONS)

WHEREAS the Council passed Resolution No. 2012-147 at its Regular Meeting held Monday, March 5, 2012, authorize amendments to By-Law No. 2007-89;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1. Section 1(e) of By-Law No. 2007-89, is hereby deleted and the following inserted in lieu thereof:
 - "(e) "Park" means the standing of a motor vehicle, whether occupied or not, with or without the engine activated."
- 2. Section 1 of By-Law No. 2007-89, is hereby amended to including the following:
 - "(f) "Accessible aisle" means a flat, hard surface dedicated to pedestrian access only."
- 3. Section 2 (b) and (c)(ii) of By-Law 2007-89, are hereby deleted and the following inserted in lieu thereof:
 - "2.(b) A designated parking space on municipal or private property shall be of the dimensions described in Schedule "A", however, this section shall not apply to any parking space that was in compliance with the previous Disabled Persons Parking By-Law on the day of passing of this by-law.
 - (c) (ii) On streets and highways, as described in Schedules "B" and "C" by The Corporation of the City of North Bay."
- 4. Schedule "A" of By-Law No. 2007-89, is hereby deleted and the following is inserted in lieu thereof:
